Deputy Secretary, DAY-NULM visits Kerala

Bubul Das, Pan Shop (Jorhat, Assam)

Bubul Das, a street vendor has been running a pan stall at AT Road, Teok Telia Gaon in Assam since 2018. He started his business with a small capital and earned daily profits of ₹ 100-150 only per day. He faced many challenges meeting his family expenditure on such a small income. After taking a loan under the PM SVANidhi scheme, Bubul was able to expand his pan stall and added some additional stocks for sales. His daily profits increased to ₹ 250-300 per day, and with this income, he is now able to support his family comfortably. Bubul has faced many challenges along the way, but he was able to overcome them with the improved business that he was able to setup with the help of PM SVANidhi loan. This scheme has helped many street vendors become self-reliant, and Bubul is a shining example of the success. He has already paid the 1st & 2nd tranches of his loans, and he is eligible to avail the 3rd trance loan.
