# Standard Operating Procedure Manual (SOP) Implementation of Seed Capital Assistance under

**Convergence of DAY-NULM with PMFME Scheme** 

Micro Food Processing Units owned and operated by Individual SHG Members, Groups (Members of the same SHG) or Activity Groups (Members from multiple SHGs) are eligible to apply for Seed Capital Assistance @ Rs. 40,000 per SHG member for working capital and purchase of small tools from PM FME Scheme of Ministry of Food Processing Industries (MoFPI) in convergence with DAY-NULM scheme of Ministry of Housing and Urban Affairs (MoHUA) as per the guidelines circulated to States/ UTs vide letter dated 21.06.2021. The operating procedure for Seed Capital Assistance in accordance with the said guidelines has been illustrated in this SOP.

#### I. Seed Capital

Self-Help Groups (SHGs)/ SHG members presently engaged in Micro Food Processing (MFP) activities with an **experience of at least one year** are eligible to apply for seed capital under the PMFME Scheme (refer 2.1.1 of convergence guidelines for details). Food processing activity refers to the transformation of raw materials or agri-produce into any other consumable form that has a shelf life and packaging that is done for the market. An illustrative list of activities excluded for seed capital assistance and the activities eligible for assistance in the same category is given below as example for better clarity:

## III. Mobilising/Preparation of applications of MFPU applications by SHG/Federation

- MFPU owned by individual SHG members, groups (members of same SHG), as well as Activity Groups (members from multiple SHGs) are eligible for seed capital assistance. Though the members of different SHGs can constitute an Activity Group, all such SHGs should be affiliated to a single ALF.
- Resource Organisations (ROs)/ Community Organisers (COs)/Community Resource Persons (CRPs)/office bearers of SHGs would


#### **Documents Check List**

facilitate the MFP units to prepare applications in hard copies in the prescribed format (Application Form I & II) along with declaration signed by the concerned SHG office bearers.

- The approximate turnover of the MFPU shall be calculated based on the gross sales value of enterprise in the last financial year (12 months cumulative sale value).
- The list of **Product Categories/ Sub-Categories can be referred in** *Annexure* for filling-out the application in hard copy.
- The application should be completed in all aspects including all related figures to avoid confusion during online entry at ULB level.
- The amount of seed capital requested for working capital as well as for purchase of small tools and equipment should be in adherence with clause 2.1.3 of the convergence guideline.
- ROs/COs/CRPs should support the MFPUs not only in preparing the application but shall also facilitate in developing Enterprise Upgradation Plan. The enterprise upgradation plan should be consistent with the eligibility prescribed under the Seed Capital component.
- A photograph of the enterprises depicting the nature of enterprise and products being manufactured should be submitted along with the application.
- Copy of the passbook of the bank account of proprietor (for individual enterprise)/ Enterprise bank account (for Group enterprise of members from same SHG and activity group) also should be enclosed along with the application.
- In case of enterprises having FSSAI licence and GST registration, copy of concerned certificates also should be enclosed. Or else, MFPU should be encouraged to apply for FSSAI license at the earliest.

- The applications approved in the meeting of the SHGs (Form I & II) shall be forwarded to the ULB by ROs/COs/CRPs concerned.
- ULB would scrutinize the hard copy applications received and accord necessary approval. It will also digitize the approved applications for uploading on NULM MIS.



#### IV. Entry of online application at ULB


- Application for seed capital shall be processed in online mode only. A separate module has been developed on NULM MIS for this purpose.
- Login credentials shall be provided to the users at ULBs and SULMs for processing applications on NULM MIS.
- The applications of the MFPUs approved by the SHGs will be submitted to ULBs by ROs/ COs/ CRPs in hard copies. The ULBs after their scrutiny will allow entry of application in the NULM MIS portal.
- Soft copy of application (Form I & II) along with approval of ULB, photograph of the enterprise, FSSAI license, GST registration certificate (FSSAI &GST, if available) should be ready for uploading while filling the online application.
- Details of the SHGs and its Members will be picked from the existing SHG database in the NULM MIS. There will not be provision for manual entry of these details.
- Details like name of SHG Members, Aadhaar number, phone number etc. will be auto populated from the existing SHG data base. In case these are not entered in the NULM MIS, ULB should ensure correct and complete MIS data entry before filling the online applications. Online application will be registered only after successful Aadhaar Authentication and Mobile Number Validation.
- Applications of the MFPUs owned by individual SHG members, Groups (members of same SHG), and Activity Groups (members from multiple SHG) can be submitted online under the respective categories available in the drop down.
- Once applied for seed capital either as individual, group, or activity group, such members will not be available to pick from MIS database to submit another application.


## V. Recommendation by SULM

- All the applications submitted by the ULBs will be available for recommendation at SULM login. There is no edit option at the SULM level. However, SULM may reject the applications citing reasons.
- The applications rejected at the state level, would be available again at ULB level for reconsideration/ rectification.
- After approval of a set of applications, SULM shall download the summary of approved applications from the portal. This summary of proposal signed by mission director/ designated officer shall be forwarded to SNA through the online portal.
- Signed copy of the summary of application should be uploaded on the portal also. It will be visible for reference to all stakeholders.



#### VI. Approval by SNA

- All the applications recommended by the SULM will be available to SNA for approval/rejection.
- Report of the applications approved/rejected by SNA will be available in the report section of all stakeholder's login.
- Rejected applications (with reasons for rejection) will be available to SULM for review. SULMs can either permanently close these applications, or forward it to ULBs for re-consideration



#### VII. Fund release

- Amount sanctioned by SNA against the approved applications would be transferred into the bank account of SULM.
- SULM on receipt of the amount would transfer this money to the concerned Federation's (ALF/CLF) bank account within 10 days. For MFPUs which do not


**possess FSSAI registration/ license, at the time of application**, SULM will verify FSSAI license status and transfer the sanctioned amount for such MFPUs after they successfully get the FSSAI registration/ license.

- In case of enterprises having individual members, ALF/ CLF will transfer the seed capital amount directly to the bank account of the beneficiaries. In case of group enterprises/ activity groups the sanctioned seed capital amount would be transferred to the bank account of Enterprise.
- SHGs and federations will maintain a separate ledger for the loan released under PMFME. Similarly, the separate account will be maintained at ALF/ CLF level on the grant received from PMFME through SULM.



#### VIII. Online entry of fund release data

- As soon as the funds are released by PMFME, SNA and SULM would enter the release details on the PFMS module in the NULM MIS.
- Fund release details from ALF and CLF to the Enterprise will be collected in the prescribed format by ROs/ COs/CRPs.
- The data collected will be entered in the NULM MIS Module by ULB from their login.



#### IX. Utilization

- One month's interest-free lock-in period will be available for the beneficiaries to complete procurement and installation of tools/equipment and completing the upgradation process.
- ULBs will collect the details of the fund utilization by MFPUs through ROs/ CRPs/COs and enter data through ULB login.

### X. Repayment

- As per the PMFME scheme convergence guideline, a maximum of 6% of interest can be charged on the seed capital loans.
- ROs/ COs/CRPs will support the SHGs for calculating the EMI schedule of each beneficiary.
- ALFs shall recover the EMI through SHGs. ROs/ COs/ CRPs shall extend support in this regard.
- The ROs/ COs/ CRPs/ALF office bearer designated to keep the PMFME loan ledger should prepare the repayment report in the prescribed format, and forward to ULB before 15<sup>th</sup> of every month.



## XI. Dashboard

- Dashboard depicting overall status of PMFME implementation is incorporated in the IT Module on NULM MIS.
- It has been linked with real time progress in applications mobilized, recommended by ULB and SULM, and approved by SNA.
