MoHUA Issues Advisory for the Safety and Well-Being of Urban Homeless amidst the Sweltering Heat

To safeguard the vulnerable population during the scorching summer months, MoHUA has issued an advisory concerning the protection and well-being of urban homeless individuals during heat waves. To effectively combat the challenges posed by scorching temperatures, the advisory outlines essential arrangements for urban homeless in shelters. Key measures include sufficient water supply, cooling facilities with fans and water dispensers, and vector control measures to minimize health risks. More steps have

been taken, like staff training on identifying and responding to heatrelated illnesses, awareness public campaigns and community collaboration efforts to strengthen the support system.

From Struggles to Success: Mutiya Devi's Journey with PM SVANidhi

Mutiya Devi hails from Chas, Jharkhand, and her life took a positive turn amidst the challenges of COVID-19. She is the sole breadwinner of the family, as her husband suffers from a physical disability. Before the pandemic, she struggled to make ends meet with a meagre income of INR 200-300 per day from vending. Additionally, the lockdown brought financial strain and anxiety. Her ray of hope came in the form of PM SVANidhi, discovered through a community resource person. With the first loan of INR

10,000, she revitalized her purchasing business, bulk quantities of vegetables and adopting mobile contact delivery. Now, her daily earnings have doubled to INR 500, enabling her to afford her children's education and her husband's medical expenses. Mutiya Devi sees PM SVANidhi as a golden opportunity for street vendors like herself to transform their lives.






Resilience and Renewal: Manik Pawar's Success Story with PM SVANidhi
