




Journey of Medara Geetha: A Story of Resilience and Success

Since the start of the COVID pandemic, life was been tough for Medara Geetha from Anantpur, Andhra Pradesh. She struggled to support her family financially. 1st phase of micro credit of Rs. 10,000/- under PM SVANidhi aided her to restart her bamboo products vending activity and 2nd phase credit of Rs. 20,000/- enabled her to sustain the economic activity in the long run, pulling her out of adversities and contributed for the betterment of the whole family under SVANidhi se Samriddhi. With regular repayments and digital transactions, she got incentives & cash back. Also, the family members got enrolled under social security schemes per member through socio economic profiling. Now she earns Rs.1300/- to 1500/-profit per day.
