From the Centre Ministry signs MoU with NAREDCO



The Ministry signed an MoU with National Real Estate Development Council (NAREDCO) on September 27. 2018 in Mumbai in the presence of Hon'ble Minister of State (IC), Shri Hardeep Singh Puri. Under this initiative 2,50,000 urban poor are proposed to be trained over a period of 3 years across RPL, up-skilling and fresh trainings thereby strengthening the skill training and employment opportunities in the construction sector.

NASVI national convention inaugrated in New Delhi

Shri Hardeep Singh Puri inaugurated a two-day National Convention of National Association of Street Vendors of India (NASVI) in New Delhi on September 18, 2018. Stating that the government is committed to provide an enabling environment for street vendors, Hon'ble Minister informed that a workshop of State UD Ministers will be held within the next three months to review the implementation of the Street Vendors Act, 2014 and discuss the way forward.

National Hawkers Federation meeting

A meeting with the representatives of the National Hawkers Federation was held on September 24, 2018 under the chairmanship of JS, Shri Sanjay Kumar to discuss the issues relating to implemention of the Street Vendors Act, 2014.

Progress So

Rajasthan: An MoU was signed between the SULM and Sector Council Green Jobs (SCGJ) on September 20, 2018 to train 2,000 urban youth as skilled technicians in the field of non-conventional energy. Rajasthan has huge potential for solar power generation and both the private aovernment and players are activey working to develop this field thereby creating a market for skilled human resource.

Creating Green Livelihoods - Case of Chhattisgarh

"Didi Bartan Bank" was inaugurated by Hon'ble Chief Minister of Chhattisgarh, Dr. Raman Singh on September 25, 2018. The initiative aims to minimize the use of single use disposable cutlery such as plastic glasses, spoons, thermocol plates etc, which contribute to environmental pollution.

Two Area Level Federations -"Laksh" "Sunhera and Jeevan" Ambikapur from have procured steel utensil sets out of their revolving fund which will be supplied on rental basis for various social events and trainings.

Andhra Pradesh: In order to show solidarity and support Kerala financially in its relief activities, the MEPMA staff donated their one day salary amounting to Rs. 3,87,771/- and SHG members donated 1 rupee each, totalling to Rs. 17,21,457/-. Thus, a total of Rs. 21,09,228/was donated towards the relief fund.

Karnataka: A two-day hands-on training program on "DAY-NULM MIS" was organised on September 24, 2018 at State Institute of Urban Development (SIUD), Mysuru. 50 participants from various ULBs and skill training centres from the state attended the programme. Participants were apprised of the process flow of data entry, validation checks new introduced and recent developments in the NULM MIS portal.

Training of street vendors in Jharkhand

Trainings were organised in Medninagar, Jamshedpur and Basukinath during September 15-30, 2018 for street vendors to create awareness regarding food safety standards, waste disposal, maintenance hygiene and the provisions of Street Vendors Act, 2014. A total of 1,427 street vendors were trained.
